Terms of Credit Agreement

Credit Line and Terms of Payment

1. Customer will abide by the conditions as to date of payment and pay interest on overdue accounts as recorded on Tuffco Inc Invoices.
2. If the customer fails to abide by the conditions of the invoices, or this credit agreement, or if Tuffco in its absolute discretion considers that the customer will be unable to pay amounts due and owing, Tuffco has the right to revise or revoke these credit arrangements. Tuffco will give the customer 48 hours prior notice of the exercise of this right. During this 48-hour period and thereafter, all new services will be provided on a C.O.D. basis.
3. The customer hereby authorizes Tuffco Inc to obtain credit reports in connection with this application for credit.
4. The customer shall notify Tuffco Inc immediately of any change of postal or email address, and failing such notification any notice to the customer is effectively sent if by post or email to the customer's last known address.
5. Tuffco agrees that any subsidiary, associated or affiliated companies named by the customer shall be entitled to participate in the credit privileges of the customer, but the customer agrees to be fully responsible for payment of any charges incurred by such companies, and hereby guarantees payment thereof.
6. In the event that it becomes necessary for Tuffco Inc to refer the account to a collection agency and/or attorney, all reasonable collection and legal fees are to be paid by this debtor. The customer agrees that the Courts of the Province of Ontario will have jurisdiction to hear and determine any actions by Tuffco Inc for recovery of amounts owing.
